- c) Final merit list of the qualified candidates shall be prepared on the basis of total marks secured by the candidates in both the stage of examination.
- d) After arranging the candidates in order of merit as per (c) above, number of candidates to be declared successful shall be equal to the number of vacancies in each category.
- e) In the event of any vacancy notified for recruitment remains unfilled due to non- joining of selected candidate, the next candidate in the merit list shall be considered for appointment. However, appointment of such candidate shall be only on refusal / declining offer of appointment and no wait list or approved panel shall be maintained.
